2. Approve POA No. 14-11: Budget Transfer Request in the amount of \$75,000, for additional funding for wastewater residuals processing at the Water Reclamation Facility by BCR Environmental Corporation, of Jacksonville, Florida.
3. Ratify the sale of 23 vault transformers and 1 pole-mounted transformer, which were deemed obsolete.

3. Approve POA 18-17: (a) The 2020 Employee Benefit Plan Overview and Recommendations prepared by Relation Insurance Services of Florida, Inc., of Stuart, Florida. (b) Payment of administrative fees to Blue Cross and Blue Shield of Florida, Inc. dba Florida Blue, of Jacksonville, Florida, in the amount of \$65.05 per employee per month estimated to be \$221,690.40, based upon enrollment of 284 members, subject to enrollment fluctuations for the period of January 1, 2020 through December 31, 2020, with a rate guarantee for two years through December 31, 2021; and payment of an additional \$2.00 per member per month, estimated to be \$6,816.00, based upon enrollment of 284 members, for telemedicine services for the period of January 1, 2020 through December 31, 2020. (c) The BlueMedicare Group Master Agreement with Blue Cross and Blue Shield of Florida dba Florida Blue, for the provision of Medicare Supplement plans to the retirees of FPUA. The premiums for the plans are fully paid by the retirees of FPUA, and are not expected to exceed \$45,000 annually. The term of this

agreement is January 1, 2020 through December 31, 2020, with unlimited automatic one-year renewal options. (d) The Administrative Services Only (ASO) Dental Administration Fee Structure with Florida Combined Life Insurance Company, Inc., of Jacksonville, Florida, for a not-to-exceed amount of \$23,500 annually, based on a rate of \$6.33 per employee per month, through December 31, 2021. (e) The Cancer Guardian Employee Master Application with Wamberg Genomic Advisor, Inc. of San Diego, CA 92122, to add a voluntary worksite benefit offering effective January 1, 2020, for genetic cancer screening, support and associated benefits, with the full cost of the premium to be paid by the employee. (f) The LifeLock Employer Benefits Agreement with Symantec Corporation, of Mountain View, California, to add a voluntary worksite benefit offering effective January 1, 2020, for identity theft protection, with the full cost of the premium to be paid by the employee.
