1. Call to Order

Becky Kauffman called the meeting to order at 5:33 p.m.

2. Public Comments

None made

3. Approve minutes of meeting held November 14, 2019

Peggy Crabtree made a motion to approve the minutes of the meeting held on November 14, 2019. The motion was seconded by Glinda Felty. **All ayes.**

4. Consider plans for 421 S. College Street

Becky stated that the freight depot is a contributing member of the Ellis County Courthouse National Register District so it is eligible to receive the tax credits if Mr. Autrey wants to pursue them. The combined credits amount to 45% of the total cost of the project. Jeff Smith noted that rehabilitating the freight depot is a tremendous undertaking and Dusty agreed. Jeff then questioned Dusty and Mr. Monsanto about the dimensions of the opening for the doors and whether they would be changed. There was much discussion about the proposed doors and how they would be configured. Peggy Crabtree offered that a better solution if it was possible would be to insert the proposed door sections but change the existing sliding doors from inset to outset and use them to cover the new doors when the building is not in use. Mr. Monsanto said that was doable and everyone agreed that would be a good alternative for the doors on both sides of the building. Dusty said his intent is to leave everything salvageable there and to replace non-salvageable elements in kind. There was discussion of the ramps, decks, and stairs and their placement for clarification purposes. Jeff Smith asked about a discrepancy in the two detail drawings of the rails. Mr. Monsanto clarified that the proper dimensions are those in A1.1; the Commission agreed that is the more appropriate version. Jeff Smith asked if a canvas awning could be used on the south elevation; Becky Kauffman suggested starting the roof extension east of the first set of windows on the south side. There was some discussion of the west elevation and the door that is there. Mr. Monsanto said there was a barn door like the other two sides behind the sheet metal door shown in the photo. On the east elevation the Commission encouraged Dusty and Mr. Monsanto to be consistent

with the direction of the skirting/underpinning and suggested that the horizontal orientation would be most appropriate. Anita was instructed to write up notes regarding the recommendations and send them with marked up elevation plans to Dusty and Mr. Monsanto for revision. Plans will be resubmitted after they are revised and the Commission will reconsider them at that time.
