MC19-061 Nicole Recker, Vice President of Marketing & Administration provided a report on the plans for an efficiency study to define the needed updates and changes to the bus stop pads, benches and pavilions; Colorado and Brinker pedestrian and trail crossing improvements and the plan coordination with the City; and Bonnie Brae service route changes in coordination with the construction completion schedule where a site visit is scheduled for today.
